- Is geared toward the success or failure of a partisan political party, group or candidate; or
- Incites hate.

# TERMS of Use

Kollywood Cinema ., its subsidiaries, licensees and affiliated companies (collectively, “Kollywood”, “we”, “our”, or “us”) have adopted these Terms of Use (these “Terms”) in order for each visitor to one of our website, knows what to expect from your visit to or use of the Services.
